

Maker's Lab and Innovation Incubator Liability Waiver

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY CONSENT AGREEMENT ("AGREEMENT")
IN CONSIDERATION of being permitted to participate in any way in the activities of the Maker's Lab and Innovation Incubator, I, for myself for personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I understand the nature of the Maker's Lab and Innovation Incubator activities and that I possess the necessary qualifications and / or training for the particular activity that I plan to engage in, or equipment that I plan to use, and that I have no knowledge of any medical or behavioral condition that would render my participation unsafe or potentially dangerous to myself or others. I further agree and warrant that if at any time I believe that my physical or mental condition would render my participation in any activity or use of equipment unsafe, I will immediately discontinue further participation in the Activity or use of equipment.

FULLY UNDERSTAND THAT: (a) these activities may involve risks and dangers of serious bodily injury, including permanent disability, and death ("risks"); (b) these risks and dangers may be caused by my own action or inaction, the action or inaction of others participating in the activity or overseeing the Maker's Lab and Innovation Incubator, or the condition in which the activity takes place; (c) there may be other risk and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibilities for losses, costs, and damages I incur as a result of my participation or that of any minor individual under my direction participating in the activity or using the equipment.

HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE THE CENTER FOR DISCOVERY, INC, THE CENTER FOR DISCOVERY MAGNET SERVICES CORPORATION, or any of its affiliated corporations, THE MAKER'S LAB AND INNOVATION INCUBATOR, their respective directors, agents, officers, members, volunteers, and employees, and other participants (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY MY NEGLIGENCE.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
